We can provide remittance services to you as an Aggregator, Master Agent or Affiliate if you have approval from your Central Bank / financial regulator (as appropriate) to provide money service business, or we can register you under our licence if you can meet our "Affiliate Requirements". We strongly advise you to take all your documents to an advocate/lawyer who is experienced in the Financial Service sectors in relation to the Payment Service Directive (PSR 2009) in your country for correct guidelines and assistance in preparing documents before sending them to us. Some of the key benefits we can offer are as follows:

The UK FSA and EU financial regulators require all money remittance companies to have credible IT systems in place with a reputable service provider which allows various AML checks to be performed against HM Treasury Sanctions List, Investment Ban List, OFAC Sanctions list, UN Sanctions list, PEP sanctions list and others. Further checks include PSR Regulation 2009 compliance checks, data protection compliance, FOS & ICO compliance, electronic address verification checks when registering a customer for the first time and many more compliance functionalities for SAR compliance. You are also required to submit the GABRIEL report to the regulator every month to declare your sales figures and safeguard remittance funds. Therefore, it is very important for you to trade with service providers who have this infrastructure in place and who make this available to you. AN Express Ltd's Online Remittance Platform has been built with all the above functions, and we have been in the remittance business since 1996.
- 2. As a FSA authorised Payment Institution, we provide remittance services with competitive fees and exchange rates; we are affiliated with reputable banks around the world with central bank approval. In addition to the above we also provide other essential tools to support your business' day to day needs.
